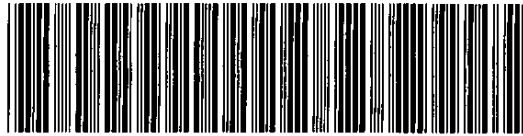



Additionally, the registered agent has changed from Bluefin Investment Group Inc to Orion Legacy Group Inc.






