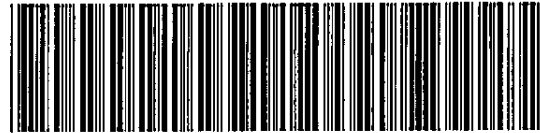

Thank you very much for your kind courtesies and attention to me in regards to the help provided in the filings of the above two partnerships.


I am attaching the following documents for your review and filing:
