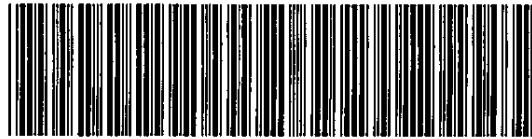

LG 75, LIMITED, a Florida limited partnership.**


1. This is the Fourth Amendment to the Amended and Restated limited partnership, the name of which is **LG75 LIMITED**.


