

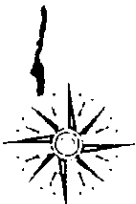

I am in receipt of your letter dated July 24, 2018 regarding Boulevard, LTD.


The Certificate of Dissolution for Boulevard, LTD. adheres to Florida Statute 620.1203 as follows:

- (1) A certificate of dissolution shall be filed with the Department of State in accordance with s. 620.1801 (2) and set forth:
 - (a) The name of the limited partnership.
 - (b) The date of filing of its initial certificate of limited partnership.
 - (c) The reason for filing the certificate of dissolution.
 - (d) Any other information as determined by the general partners filing the statement or by a person appointed pursuant to s. 620.1803 (3) or (4).

I filed the Certificate of Dissolution for Boulevard, LTD. simultaneously with the request to have the General Partner, 5636 Boulevard, LLC dissolved. 5636 Boulevard, LLC has since been dissolved and the limited partnership (Boulevard LTD.) should have been dissolved simultaneously therewith absent some legal defect in failing to comply with the partnership statute Chapter 620. 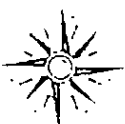


