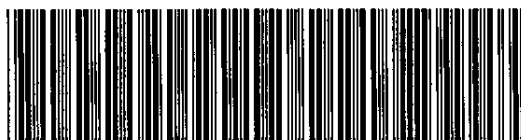

WOLFS' LAIR, LTD.**


(A Florida Limited Partnership, Document No. A05706)

This certificate amends the certificate of limited partnership of Wolfs' Lair, Ltd. 
