**CERTIFICATE OF AMENDMENT
TO
AMENDED AND RESTATED CERTIFICATE OF LIMITED PARTNERSHIP

This Certificate of Amendment has been executed and is being filed pursuant to the provisions of Section 620.1202 of the Florida Statutes. Southside Shopping Center, Limited, whose original certificate was filed with the Florida Department of State on July 27, 1977, and assigned Florida document number A05883, adopts the following Amendment to its Certificate of Limited Partnership:

FIRST: LIMITED LIABILITY LIMITED PARTNERSHIP STATUS/NAME OF PARTNERSHIP: The Partnership hereby elects to be a "limited liability limited partnership." The name of the Partnership shall be Southside Shopping Center, LLLP.

SECOND: DATE OF DISSOLUTION: The Partnership shall continue (a) until the Partnership is dissolved pursuant to the terms of the Limited Partnership Agreement for Southside Shopping Center, LLLP, (b) until disposition of all or substantially all of the Partnership's assets, or (c) until December 31, 2013, whichever first occurs.

THIRD: This Certificate of Amendment shall be effective at the time of its filing with the Florida Department of State.
