

Southside Shopping Center, LLLP whose original certificate was filed with the Florida Department of State on July 27, 1977, and assigned Florida document number A05883, adopts the following Amendment to its Certificate of Limited Partnership:

FIRST: DATE OF DISSOLUTION: The Partnership shall continue (a) until the Partnership has dissolved pursuant to the terms of the Limited Partnership Agreement for Southside Shopping Center, LLLP, (b) until disposition of all or substantially all of the Partnership's assets, or (c) until December 31, 2020, whichever first occurs.

SECOND: This Certificate of Amendment shall be effective at the time of its filing with the Florida Department of State.


