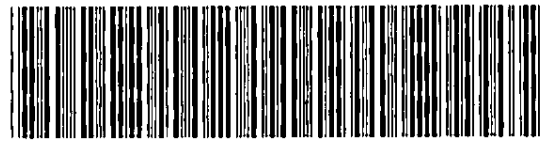

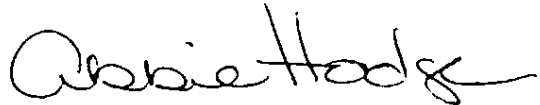

3. Paragraph 2 of the Certificate is hereby deleted in its entirety and the following substituted in lieu thereof:

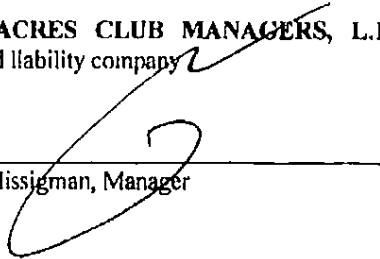
