Pursuant to the provisions of Florida Statutes §620.8907, **LEXMERGE PARTNERSHIP 20114**, a general partnership existing under the laws of the State of Florida (the "Merged Entity"), and **CEDARWOOD APARTMENTS, LTD.**, a limited partnership existing under the laws of the State of Florida (the "Surviving Entity") (the Merged Entity and the Surviving Entity are referred to collectively as the "Constituent Entities"), adopt the following Statement of Merger for the purpose of merging the Merged Entity into the Surviving Entity:
