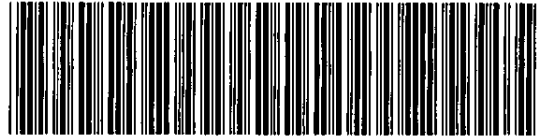



**FIFTEENTH AMENDMENT TO THE LIMITED
PARTNERSHIP AGREEMENT OF
SUGARPLUM PROPERTIES ASSOCIATES, LTD.
(ACT OF CORRECTION)**

The Fifteenth Amendment to the Limited Partnership Agreement of Properties Associates, Ltd. (hereinafter referred to as "the Amendment"), made, executed and entered this on the dates and at the places indicated hereinbelow by and between Charles B.
