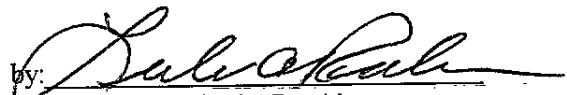
4. **Withdrawal Date.** The withdrawal of Leslie A. Rubin as a General Partner occurred on MAY 1, 1998.
