FIRST: DATE OF DISSOLUTION: The Partnership shall continue (a) until the Partnership is dissolved pursuant to the terms of the Limited Partnership Agreement for Mabel Groves, LLLP, (b) until disposition of all or substantially all of the Partnership's assets, or (c) until December 31, 2035, whichever first occurs.
