Dear Ms. Harris:

Last week, my client, Hickory Knoll Apartments, Ltd., received a notice that the partnership could no longer conduct business for failure to file the annual report and the application for reinstatement. The notice was sent to the partnership but at an incorrect address. Apparently, the prior notices were also sent to the incorrect address.

After explaining the situation to your personnel, I was told to have my client complete the application for reinstatement, send it and a check for \$526.25 to your office, along with a letter re-explaining the reason for the incorrect address and why it was through no fault of the partnership so the penalties should be waived.

In April 1998 some of the limited partners of Hickory Knoll filed an amended certificate of limited partnership with your office, changing the ownership interests of the limited partners and adding a new general partner, all without proper authority or consent of the general partners. The general partners learned that the amended certificate had been filed and in May 1998 filed another amended certificate voiding the April 1998 certificate and reinstating the partnership as it had been prior to the April 1998 amendment. Simultaneously, a lawsuit was filed in the Circuit Court in and for Duval County seeking an injunction, temporary and permanently, and declaratory relief. In June 1998 the Court entered a temporary injunction enjoining the limited partners from further amending the certificate of limited partnership.

The registered agent for the limited partnership was not changed and the May 1998 amendment to limited partnership clearly nullified the April 1998 amendment to the limited

partnership certificate. However, it appears that the address that the annual report and the notices of delinquency and consequences for failing to file the annual report were sent to the address provided in the April 1998 amendment to limited partnership certificate.

My client probably still would not have received notice of the failure to file and the termination status had it not been for the fact that there is a new manager at the address where the last notice was sent; he called to say he had received it and did not know why it had been sent to his address.

Enclosed for your information are copies of the April and May 1998 amendments to limited partnership and the Temporary Injunction Order. In addition, enclosed are the completed Application For Reinstatement For Limited Partnership, a check in the amount of \$526.25 from my client and a firm check for \$8.75 for a Certificate of Status.

Your assistance in removing the penalties is greatly appreciated. I look forward to receiving the Certificate of Status showing that Hickory Knoll Apartments, Ltd. is in good standing and confirmation that the penalty has been removed.


