**CERTIFICATE OF LIMITED PARTNERSHIP
OF

This Certificate of Limited Partnership is made and entered into this 26 day of January, 2007, by and between **STEPHEN P. 7. The Partners may, by a vote of the majority of the partnership interests, elect to continue the Partnership beyond the fifty (50) year term. If the Partners vote to continue the Partnership beyond the fifty (50) year term, the Partnership's existence shall be for such time as voted by the Partners, unless sooner terminated by law or as provided in the Partnership Agreement.
