
ARTICLE X MANAGEMENT

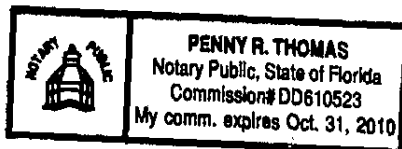
