**CERTIFICATE OF LIMITED PARTNERSHIP OF

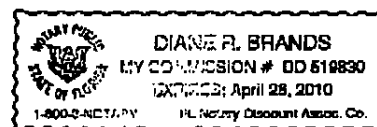


