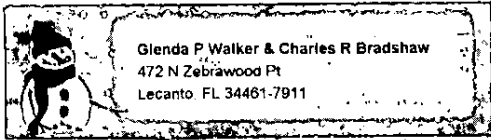

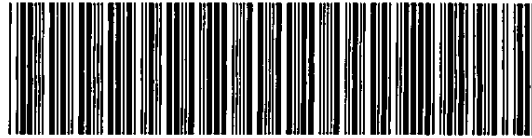

ARTICLE X MANAGEMENT



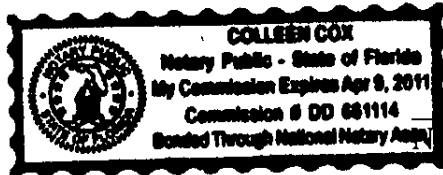
