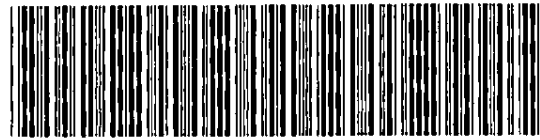

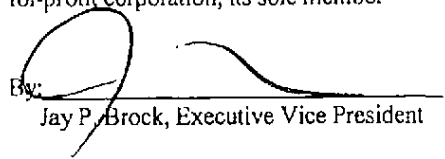
1. The current name of the Partnership is TAYLOR PLACE, LTD.
