# AMENDMENT TO CERTIFICATE AND AGREEMENT OF LIMITED PARTNERSHIP OF KENDALL INDUSTRIAL PARK, LTD., a Florida Limited Partnership

This is an Amendment to that certain Certificate and Agreement of Partnership of Kendall Industrial Park Limited, dated April 1, 1978, filed with the Sec. of State on April 13, 1979.

NOW, THEREFORE, in consideration of the sum of TEN DOLLARS (\$10.00) and other good and valuable consideration the receipt and sufficiency of which is hereby acknowledged by all, the Limited and General Partners agree as follows:

- 1. Article 1, Paragraph 1.1 is hereby modified to provide for the replacement of Jorge L. Mas with Jorge Mas, Jr., Personal Representative for the Estate of Jorge L. Mas, as a General Partner. Accordingly, upon execution of this Amendment, the General Partner consists of Thomas P. Carlos, Lawrence M. Marks and Jorge Mas, Jr., Personal Representative for the Estate of Jorge L. Mas.
- 2. Article 6, Paragraph 6.1 is hereby modified to provide that the 25 limited partnership units to be reissued as 100 units. Each Limited Partner's new interest is to be expressed as set forth in Exhibit "A" attached hereto.
- Jorge L. Mas and Irma S. Mas have caused to be provided services to the Partnership worth 13.37% of the Limited Partners' interest in the Partnership. In exchange for said services, their partnership interest shall be increased by 13.37% Limited Partnership units and all other Limited Partners' interests shall be ratably reduced. This increase shall be effective as of January 1, 1986. This date is the effective date of the ownership change and the ownership of the Limited Partnership as of January 1, 1986, except as modified by Exhibit "C" attached hereto, is to be expressed as set forth in Exhibit "B".
- 4. Article 9, Paragraph 9.2(b)(ii) is hereby modified to provide that it be deleted in its entirety and replaced with the following:

9.2(b)(ii) Each Limited Partner's total capital investment will be divided into two (2) accounts: Account "A" and Account "B". Account "A" shall reflect the total capital investment made by the Limited Partners on or before December 31, 1985; and Account "B" shall reflect the total capital investment made by the Limited Partners on or after January 1, 1986.

5. Article 9, Paragraph 9.2(b), is hereby modified to add the following new Paragraph 9.2(b)(iii):

9.2(b)(iii)(A) From Net Cash Flow (Net Sales Proceeds) totaling Ten Million Dollars or less, a return of capital shall be made to the Limited Partners equal to the total capital investment contained in their Account "A" on a prorated basis of the number of acres sold. The remaining Net Cash Flow (Net Sales Proceeds) shall then be distributed 50% to the Limited Partners and 50% to the General Partners;

9.2(b)(iii)(B) From Net Cash Flow (Net Sales Proceeds) exceeding Ten Million Dollars, a return of capital shall be made to the Limited Partners equal to the total capital investment contained in their Account "B" on a prorated basis of the number of acres sold. The remaining Net Cash Flow (Balance of Sales Proceeds) shall be distributed 90% to the Limited Partners and 10% to the General Partners.

- 6. Article 14, Paragraph 14.1(a) is hereby modified to provide that the termination date for the Partnership shall be extended from December 31, 1999 to December 31, 2009.
- 7. Article 21, is hereby modified to add the following new Paragraph 21.4: In any instance where the Agreement requires a vote of the Partners, said vote may be properly effected by proxy; ergo, any Partner entitled to vote shares may authorize another representative to act by proxy with respect to such shares. Any proxy purporting to be executed pursuant to this provision of the Agreement shall be presumptively valid.
- 8. The interest of the Limited and General Partners in the Limited Partnership shall be upon the execution of this Amendment as set forth in Exhibit "C" attached hereto and made a part hereof.
- 9. Upon execution of this Amendment, all assessments shall be made based upon the ownership interest of the Limited Partners as set forth in Exhibit "C".
- 10. Between the date of the Limited Partnership Agreement and this Amendment thereto there have been several transfers by various Limited and General Partners resulting in the current ownership interest in the Limited Partnership as set forth in Exhibit "C". Execution of this Amendment by the undersigned General and Limited Partners shall constitute ratification and approval of all such transfers.
- In all other respects the Certificate and Agreement of Limited Partnership of Kendall Industrial Park, LTD., a Florida Limited Partnership dated April 1, 1978shall remain in full force and effect. filed with the Sec. of State on April 13, 1979.
- 12. This Amendment may be executed in counterparts and when so executed, each such counterpart shall be as fully valid and binding on all parties hereto as every other such counterpart.
