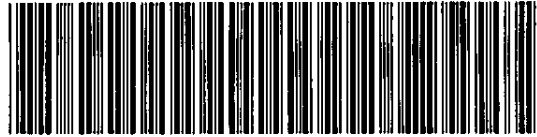




**FIRST:** The reason for dissolution is that the limited partnership no longer serves a business purpose and the General Partner desires to dissolve and partnership and distribute the assets.
