PLAN AND AGREEMENT OF MERGER

of

THE MSC INVESTMENT LIMITED PARTNERSHIP (a Georgia limited partnership)

With and into

MSCD HOLDINGS, LLLP
(a Florida limited liability limited partnership)

This PLAN AND AGREEMENT OF MERGER is hereby adopted by THE MSC INVESTMENT LIMITED PARTNERSHIP, a limited partnership organized under the laws of the State of Georgia, by resolution of its sole general partner, MSC INVESTMENT, INC., a Nevada corporation, by unanimous written consent of its Board of Directors on ________, 2008, and adopted by MSCD HOLDINGS, LLLP, a limited liability limited partnership organized under the laws of the State of Florida, by resolution of its sole general partner, MSC INVESTMENT, LLC, a Florida limited liability company, by unanimous written consent of its Members on _______, 2008. The names of the limited partnerships planning to merge are THE MSC INVESTMENT LIMITED PARTNERSHIP 2 limited partnership organized under the laws of the State of Georgia ("MSC-GA"), and MSCD HOLDINGS, LLLP, a limited liability limited partnership organized under the laws of the surviving limited liability limited partnership into which MSC-GA plans to merge is MSC HOLDINGS, LLLP.

- I. MSC-GA and MSC-WL shall, pursuant to the provisions of the Florida Revised Uniform Limited Partnership Act of 2005 and in the same manner as is provided in the Georgia Uniform Limited Partnership Act, be merged with and into a single limited liability limited partnership, MSC-FL, which shall be the surviving limited liability limited partnership upon the effective date of the merger, which is sometimes hereinafter referred to as the "surviving limited liability limited partnership", and which shall continue to exist as said surviving limited liability limited partnership under its present name pursuant to the provisions of the Florida Revised Uniform Limited Partnership Act of 2005. The separate existence of MSC-GA, which is sometimes hereinafter referred to as the "terminating limited partnership", shall cease upon the effective date of the merger in the same manner as is provided in the Georgia Uniform Limited Partnership Act.
- 2. The Cartificate of Limited Liability Limited Partnership of the surviving limited liability limited partnership upon the effective date of the merger in the jurisdiction of its organization shall be the Cartificate of Limited Liability Limited Partnership of the surviving limited liability limited partnership, and said Cartificate of Limited Liability Limited Partnership shall continue in full force and effect until amended and changed in the manner prescribed by the provisions of the Florida Revised Uniform Limited Partnership Act of 2005.
- 3. The present Agreement of Limited Liability Limited Partnership of the surviving limited liability limited partnership will be the Agreement of Limited Liability Limited Partnership of the surviving limited liability limited partnership and will continue in full force

and effect until changed, altered, or amended as therein provided and in the manner prescribed by the provisions of the Florida Revised Uniform Limited Partnership Act of 2005.

- 4. The general and the limited partners of the surviving limited liability limited partnership upon the effective date of the merger in the jurisdiction of its organization shall continue to be the general and limited partners of the surviving limited liability limited partnership, in accordance with the Agreement of Limited Liability Limited Partnership of the surviving limited liability limited partnership.
- 5. The participating percentages of the interests of the general and of the limited partners of the terminating limited partnership shall, upon the effective date of the merger and without any action by the partners, be identical in the surviving limited liability limited partnership. The general and the limited partners of the surviving limited liability limited partnership shall be identical to those general and limited partners of the terminating limited partnership. Therefore, the participating percentages of the interests of the general and of the limited partners of the surviving limited liability limited partnership shall not be changed in any manner, shall be identical with those of the terminating limited partnership as of the effective date of the merger.
- 6. The surviving limited liability limited partnership shall possess all the rights, privileges, immunities, franchises, and powers of the terminating limited partnership, and all property, real, personal and mixed, and all debts due to the terminating limited partnership, as well as all other choses in action, and every interest of or belonging to or due to the terminating limited partnership shall be deemed to be transferred to and vested in the surviving limited liability limited partnership without further act or deed; and the title to any interest therein vested in the terminating limited partnership shall not revert or be in any way impaired by such merger.
- 7. The surviving limited liability limited partnership shall thereupon and thereafter be responsible and liable for all the liabilities and obligations of the terminating limited partnership; and any claim existing or action or proceeding pending by or against the terminating limited partnership may be prosecuted as if such merger had not taken place, or such surviving limited liability limited partnership may be substituted in its place. Neither the rights of creditors nor any liens upon the property of the terminating limited partnership shall be impaired by such merger.
- 8. The Plan and Agreement of Merger of the terminating limited partnership with and into the surviving limited liability limited partnership has been fully authorized in accordance with the provisions of the Georgia Uniform Limited Partnership Act and the Florida Revised Uniform Limited Partnership Act of 2005, and in accordance with the respective Limited Partnership Agreements of the terminating limited partnership and of the surviving limited liability limited partnership. The terminating limited partnership and the surviving limited liability limited partnership hereby stipulate that they will cause to be executed and filed and/or recorded a Certificate of Merger and any document or documents prescribed by the laws of the State of Georgia and of the State of Florida, and they will cause to be performed all necessary acts therein and elsewhere to effectuate the merger.
