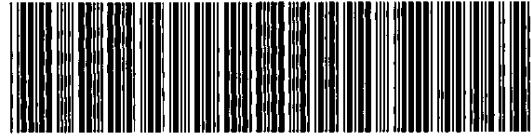



6. This First Amended and Restated Certificate of Limited Partnership has been duly executed and is being filed in accordance with Section 620.1202, Florida Statutes.



8. This First Amended and Restated Certificate of Limited Partnership has been executed and it is being filed in accordance with Section 620.1202, Florida Statutes (2009).


