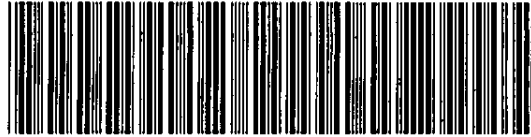

2. Effective Date. The effective date of this amendment is the date of filing the amendment with the Secretary of State.


3. All Other Terms. All other terms and conditions of the Certificate of Limited Partnership shall remain in full force and effect.
