**AMENDED AND RESTATED CERTIFICATE OF LIMITED
PARTNERSHIP OF DURNFORD ENTERPRISES, LTD.**

THIS AMENDED AND RESTATED CERTIFICATE OF LIMITED PARTNERSHIP is executed by the General Partner of that Florida Limited Partnership known as DURNFORD ENTERPRISES, LTD. (hereinafter the "Partnership") for the following uses and purposes:

1. The name of the limited partnership is DURNFORD ENTERPRISES, LTD.

2. The date of filing of the original Certificate of Limited Partnership was February 7, 1980, (hereinafter the "Certificate").

3. Amendments to the Certificate were filed on January 6, 1981, January 4, 1991, January 15, 1991 and March 6, 1991.

4. The Partners of the Partnership wish to make further amendments to the Certificate and restate the Certificate in its entirety, pursuant to Section 620.109, Florida Statutes.

Now, therefore, the Certificate is hereby amended and restated to read as follows:

I. NAME AND PRINCIPAL OFFICE

The partnership shall continue its business under the name DURNFORD ENTERPRISES, LTD. The principal office and mailing address of the limited partnership shall be 3 West Garden Street, Pensacola, Florida 32501.

II. REGISTERED OFFICE, REGISTERED AGENT
