THIRD AMENDMENT TO SECOND AMENDED AND RESTATED LIMITED PARTNERSHIP AGREEMENT AND SECOND AMENDED CERTIFICATE OF LIMITED PARTNERSHIP OF

<u>CRESTVIEW APARTMENTS, LTD.</u>
[Pursuant to the provisions of Section 620.1202, Florida Statutes]

THIS THIRD AMENDMENT to the Second Amended and Restated Limited Partnership Agreement and Second Amended Certificate of Limited Partnership is entered into this 19th day of December, 2011, by and among the undersigned parties.

RECITALS:

- A. CRESTVIEW APARTMENTS, LTD. (hereinafter referred to as the "Partnership") is a Florida limited partnership having filed its original Certificate and Agreement of Limited Partnership with the Florida Secretary of State on March 26, 1980, assigned Florida Document number A08736, and is presently existing pursuant to a Second Amended and Restated Limited Partnership Agreement and Second Amended Certificate of Limited Partnership (hereinafter referred to as the "Partnership Agreement") filed on October 2, 1980.
- B. As of the date hereof, the parties hereto consent to amend the Partnership Agreement to extend the term of the Partnership until December 31, 2043. The parties desire to amend the Partnership Agreement to reflect this extension of the term.
- C. Pursuant to an Assignment, Chec Investment Company assigned and transferred its entire right, title and interest in a 47.5% interest as a Limited Partner of the Partnership to Steven M. Reich 1976 Trust FBO Hilary Reich 19% interest, Steven M. Reich 1976 Trust FBO Lisa Reich 19% interest, and Stephen A. Bodzin 9.5% interest. The parties desire to amend the Partnership Agreement to reflect this assignment and transfer.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the undersigned parties agree and certify that the Partnership Agreement of CRESTVIEW APARTMENTS, LTD. is amended to provide as follows:

- 1. Section 5 of the Second Amended Certificate of Limited Partnership and Section 2.5 of the Second Amended and Restated Limited Partnership Agreement are amended to extend the term of the Partnership until December 31, 2043.
- 2. Exhibit A of the Partnership Agreement is hereby amended to delete the present Exhibit A and to insert in lieu thereof the Exhibit A attached hereto and incorporated herein by this reference.
- 3. It is further provided and agreed that (i) Steven M. Reich 1976 Trust FBO Hilary Reich, Steven M. Reich 1976 Trust FBO Lisa Reich, and Stephen A. Bodzin each be and are hereby admitted as Limited Partners of the Partnership to the full extent of the partnership interest acquired by each of them from Chec Investment Company; and (ii) the execution of this

Third Amendment by each partner shall constitute the agreement of such partner to all of the terms and provisions of the Partnership Agreement, as amended.

- 4. The signing of this Third Amendment by all the Partners of the Partnership (both general and limited) does and shall constitute the consent of each Partner to said admission and the amendments to the Partnership Agreement.
- 5. Except as hereby amended, the Partnership Agreement, as amended, is ratified and affirmed in all respects.
