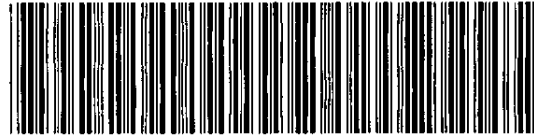

AMENDMENT TO AMENDED AND RESTATED
LIMITED PARTNERSHIP CERTIFICATE AND AGREEMENT
