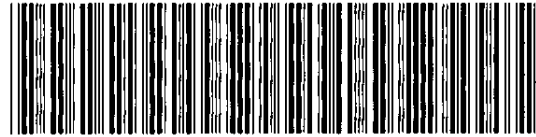





4. The conversion was approved as required by Chapter 620, Florida Statutes, and was approved in such a manner that complied with the converting organization's governing law.


