

## PLAN OF MERGER

This PLAN OF MERGER (this "Plan") is hereby adopted by JOE SAUNDERS FAMILY LIMITED PARTNERSHIP A, L.P., a Virginia limited partnership ("JS-VA"), and JOE SAUNDERS FAMILY LIMITED PARTNERSHIP A, L.L.L.P., a Florida limited liability limited partnership ("JS-FL"), for the purpose of merging JS-VA with and into JS-FL pursuant to Section 50-73.48:1 of the Virginia Revised Uniform Limited Partnership Act ("VRA") and Section 620.2106 of the Florida Statutes ("FS"). JS-FL is sometimes referred to herein as the "Surviving Organization".

- 1. Terms and Conditions of the Merger. At the Effective Time (as defined herein), JS-VA will be merged with and into JS-FL pursuant to and in accordance with the provisions of VRA § 50-73.48:1 and FS § 620.2106, in a transaction intended to qualify as an "assets over" form of merger for Federal income tax purposes, with JS-VA being treated as the "continuing" partnership, as those terms are defined in IRS Treasury Regulation 26 CFR § 1.708-1(c) (the "Merger").
- 2. <u>Parties to the Merger</u>. The name, address, jurisdiction of organization and form of entity of each party to the Merger are:
