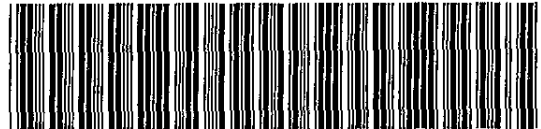

THIS AMENDMENT to the Certificate and Agreement of Limited Partnership is entered into as of this 25 day of June, 2003, by and between MARKETING DESIGNS & RESEARCH, INC., as General Partner ("General Partner") and ROSS E. ROEDER as a Limited Partner ("Limited Partner").

WITNESSETH:

WHEREAS, a Limited Partnership was formed by ROSS E. ROEDER and MARGARET D. ROEDER, as General Partners and Limited Partners, said Limited Partnership being known as ISLAND INVESTMENTS, LTD. and being filed with the Florida Department of State, Division of Corporations, on December 8, 1980 (the "Limited Partnership"); and

WHEREAS, an Amendment to the Limited Partnership Agreement was entered into on the 30th day of November, 1980 and filed with the Florida Department of State, Division of Corporations, on January 13, 1981; and

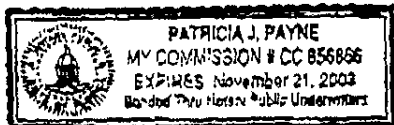

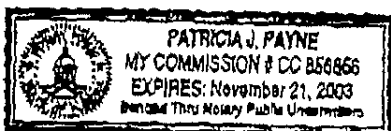
