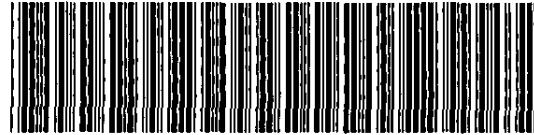


ARTICLE X MANAGEMENT

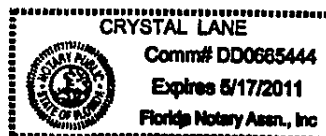


