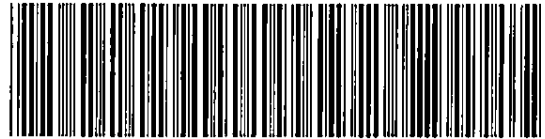



obligations, as delineated in the Partnership Agreement.





