

Pursuant to the provisions of section 620.109, Florida Statutes, this Florida limited partnership, whose certificate was filed with the Florida Department of State on April 20, 1981, adopts the following certificate of amendment to its certificate of limited partnership:

**FIRST: Amendments: Article 3., strike the entire Article and insert in lieu thereof a new Article 3.:**

“Article 3. The location of the principal place of business of the partnership is c/o Edmond J. Gong, Esquire, 6161 Blue Lagoon Drive, Suite 270, Miami, Florida 33126.”

**In Article 5., strike the entire Article and insert in lieu thereof a new Article 5.:**

“Article 5. The partnership shall commence business on the date that this Certificate is filed with both the Secretary of State of Florida and the Clerk of the Circuit Court of Dade County, Florida and shall continue until all real property owned by the partnership is sold and the proceeds of sale are distributed to all partners, unless sooner terminated by operation of law, by agreement of the parties, or by the bankruptcy of the General Partner.”

**SECOND:** This certificate of amendment shall be effective at the time of its filing with the Florida Department of State.
