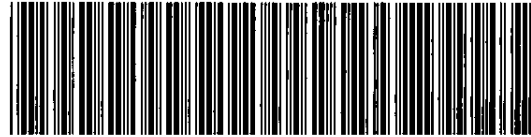

The undersigned, desiring to form a limited partnership, pursuant to the Florida Uniform Limited Partnership Act as set forth in Chapter 620, Part I of the Florida Statutes, do hereby certify:

1. The name under which such partnership is to be conducted is The Wickham Family Limited Partnership, Ltd.

2. The business of the Partnership shall be to take title to the Partnership Assets and to promote the efficient and economical management of the assets by holding them in a single entity; to avoid the division of the properties of the family of Michael Wickham and Barbara Wickham in order to promote the greater sale and investment potential of the properties; to avoid potential expensive litigation and disputes over certain properties of the family of Michael Wickham and Barbara Wickham by providing mechanisms which will provide for the management and procedures to resolve disputes; to provide mechanisms which will eliminate the potential in the future of any family member transferring his or her interest in the Partnership without first offering that interest to the other family members. 


