

## ASSIGNMENT OF LIMITED PARTNERSHIP INTEREST TER PARTNERS, LLLP

Thomas P. Rice, Jr., Limited Partner of the TER Partners, Limited Liability Limited Partnership, (the "Assignor"), grants, assigns, transfers and conveys to:

BARBARA RICE (the "Assignee") a three and 35/100<sup>th</sup> percent (3.35%) limited partnership interest (the "Transferred interest").

SALLIE RICE (the "Assignee") a three and 25/100<sup>th</sup> percent (3.25%) limited partnership interest (the "Transferred interest"),

WAYNE RICE (the "Assignee") a three and 25/100<sup>th</sup> percent (3.25%) limited partnership interest (the "Transferred interest")

in TER PARTNERS, LLLP, a Florida limited liability limited partnership (the "Partnership"), which constitutes a nine and 85/100<sup>th</sup> percent (9.85%) partnership interest in the Partnership, together with all of the Assignor's right, title and interest in the Assignor's capital account in the Partnership attributable to such Transferred Interest, all of Assignor's right to allocation of income and loss and distributions under the Agreement of Limited Liability Limited Partnership of the Partnership in effect on the date hereof, as may be amended (the "Partnership Agreement"), attributable to such Transferred Interest, and all other right, title and interest the Assignor may have in the Partnership attributable to such Transferred Interest.
