# EIGHTH AMENDMENT TO CERTIFICATE OF AGREEMENT

### OF LIMITED PARTNERSHIP

WHEREAS, the Estate of Taylor Budd Williams has assigned, sold, and transferred thirteer and three quarters (13.75%) of his interest in Southside Apartments of Marianna, Ltd., a limited partnership existing under the laws of the State of Florida, to Debora R. Williams, as Trustee of the Taylor Budd Williams Family Trust u/w/d 9/5/07, with the approval of the Managing General Partner. The original certificate of limited partnership was filed with the Secretary of State on September 9, 1981.

NOW, THEREFORE, subsection 2.02 and 3.05 are amended as follows:

# 2.02 Limited Partners

Williams, as Trustee of the Taylor Budd Williams Family Trust u/w/d 9/5/07 shall be the Limited Partners of the Partnership. All persons, firms and organizations who from time to time are Limited Partners in the Partnership are sometimes hereinafter collectively referred to as "Limited Partners" and individually as "Limited Partner." It is understood that each and every Limited Partner shall have the right to sell, transfer or otherwise divest himself or herself of his or her limited partnership interest subject only to said additional limited partners being approved by the Farmers Home Administration.
