THIS AMENDMENT is made and entered into as of the day of day of day of day of but is accepted by CENTURY WOODS, LTD. as of July 1, 2009, by and between (i) ROYAL AMERICAN DEVELOPMENT, INC., (hereinafter referred to as the "Managing General Partner"); (ii) ALBERT E. GORDON TRUST DATED 7/21/83, Glen Naroth, Trustee, (hereinafter referred to as the "Assignor"); and (iii) COUSINS, LLC, an Indiana limited liability company, (hereinafter referred to as the "Assignee" or "Substitute Limited Partner").

RECITALS:

- A. CENTURY WOODS, LTD. (hereinafter referred to as the "Partnership") is a Florida limited partnership having filed its original Certificate of Limited Partnership with the Florida Secretary of State on September 23, 1981, and is presently existing pursuant to an Amended and Restated Agreement and Certificate (hereinafter referred to as the "Partnership Agreement") filed on November 30, 1983.
- B. Pursuant to an Agreement of Assignment and Acceptance, the Assignor assigned and transferred its entire right, title and interest in a 2.375% interest as a Limited Partner of the Partnership to the Assignee.
