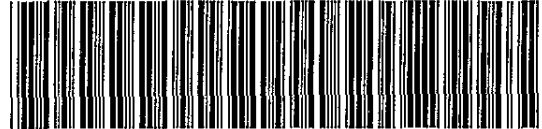

FIRSTAMENDMENT TO
JASON PARTNERS, LTD.

JAIME I. MIZRAHI, who resides at 10 Point Patriots Farm Place, Armonk, NY 10504, SCOTT D. MIZRAHI, who resides at 9449 Ridge Blvd., Brooklyn, NY 11209 and RANDY MIZRAHI, who resides at 148 Greens Road, Hollywood, FL 33021 (referred "Partners" of the "Partnership") created the Jason Partners Partnership (the "Limited Partnership Agreement") by an instrument dated July 17, 1997. The partners have retained the power to alter, amend, revoke or terminate the Limited Partnership Agreement. The Partners now desire to amend the Limited Partnership Agreement as provided herein.

Item I

The Partners desire to amend and restate Section 5 in its entirety as follows:

5. Purpose and Powers.

The purpose of the partnership shall be to purchase and manage commercial real property, to invest funds of the partnership in investment companies, buy, sell, and exchange stocks, bonds and mutual funds and all other types of securities and financial instruments designated by the partners. Any Partner acting alone shall be able to exercise voting rights in person or by proxy and shall have the authority to engage in any transactions deemed appropriate for business investments under Florida or New York Law.
