

AGREEMENT AND CERTIFICATE OF LIMITED PARTNERSHIP OF

SAND DUNES APARTMENTS, LTD.

[Pursuant to the provisions of Section 620.1202, Florida Statutes]

THIS AMENDMENT is made and entered into as of the 25th day of May, 2010, but is accepted by SAND DUNES APARTMENTS, LTD. as of January 1, 2009, by and between (i) ROYAL AMERICAN DEVELOPMENT, INC. and JOSEPH F. CHAPMAN, III, (hereinafter referred to as the "General Partners"); (ii) the Assignor Limited Partner who has executed an Assignment attached hereto, (hereinafter referred to as the "Assignor"); and (iii) EASTWOOD INVESTORS V, LLC, (hereinafter referred to as the "Assignee" or "Substitute Limited Partner").

RECITALS:

- A. SAND DUNES APARTMENTS, LTD. (hereinafter referred to as the "Partnership") is a Florida limited partnership having filed its original Agreement and Certificate of Limited Partnership with the Florida Secretary of State on November 17, 1981, assigned Florida Document Number A11512, and is presently existing pursuant to an Amended and Restated Agreement and Certificate of Limited Partnership, as amended (hereinafter referred to as the "Partnership Agreement") filed on June 28, 1982.
- B. Pursuant to an Assignment, the Assignor assigned and transferred the Assignor's entire right, title and interest to its partnership interest as a Limited Partner of the Partnership to the Assignee.
- C. It is the desire of the parties that the Assignee be substituted as a Limited Partner of the Partnership to the extent of the limited partnership interest assigned to the Assignee by the Assignor, and that pursuant to such desire, the Partnership Agreement be amended to reflect said substitution and the withdrawal of the Assignor as a Limited Partner of the Partnership.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the undersigned parties agree and certify that the Partnership Agreement of SAND DUNES APARTMENTS, LTD. is amended to provide as follows:

- 1. The Assignor Limited Partner, who has executed an Assignment hereby withdraws as a Limited Partner of the Partnership. The Partnership hereby accepts such withdrawal and said Assignor shall hereafter cease to be a Limited Partner of the Partnership.
- 2. Schedule A of the Partnership Agreement is hereby amended to delete the present Schedule A and to insert in lieu thereof the Schedule A attached hereto and incorporated herein by this reference.

- 3. It is further provided and agreed that the Assignee shall be and hereby is a substitute Limited Partner of the Partnership to the full extent of the limited partner interest assigned by the Assignor; (i) the signing of this Amendment by the parties hereto does and shall constitute the consent of all Partners to said substitution; (ii) any present or future references to the terms "Partner(s)" or "Limited Partner(s)" by the Partnership Agreement, or any amendment thereto, shall be deemed to include the Assignee to the extent of the limited partner interest assigned by the Assignor; and (iii) the execution of this Amendment by the Assignee shall constitute the agreement of the Assignee as a Limited Partner, to all of the terms and provisions of the Partnership Agreement, as amended.
- Except as hereby amended, the Partnership Agreement, as amended, is ratified and affirmed in all respects.

IN WITNESS WHEREOF, the parties hereto have executed this Amendment under seal effective as of the date hereinabove first written.
