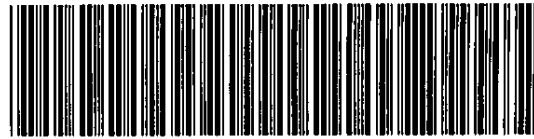

Pursuant to the provisions of Sections 620.1202 and 620.1803, Florida Statutes, **Tallahassee Single Day Surgery, Ltd.**, a Florida limited partnership (the **Partnership**), whose certificate was filed with the Florida Department of State on November 18, 1981, and assigned Florida document number A11525, was administratively dissolved on September 27, 2013, and adopts the following Certificate of Amendment to its Certificate of Limited Partnership.

1. This Certificate of Amendment amends the provisions in the Certificate of Limited Partnership filed with the Department of State to reflect that:
  - a. the Partnership's corporate general partner, T.S.D.S., Inc., whose Articles of Incorporation were filed with the Florida Secretary of State on June 5, 1987, and assigned Florida document number J76263, was administratively dissolved on September 27, 2013;
  - b. pursuant to Section 620.1803(3), F.S., **A. E. Deeb** has been designated as the Authorized Person to wind up the Partnership's activities; and
  - c. the street and mailing address of the Authorized Person is 1630 Plaza Drive North, Tallahassee, Florida 32308.
2. This Certificate of Amendment shall be effective as of the date of filing with the Florida Department of State.
