AMENDMENT TO LIMITED PARTNERSHIP AGREEMENT AND CERTIFICATE OF LIMITED PARTNERSHIP OF DANZANSKY FAMILY ASSOCIATES LTD.

THIS AMENDMENT is made and entered into for all purposes and in all respects as of the 1st day of January, 2002, by and among the undersigned parties.

<u>RECITALS:</u>

A. Danzansky Family Associates Ltd. (the "Partnership") is a State of Florida limited partnership formed and presently existing pursuant to an Amended and Restated Limited Partnership Agreement (the "Agreement") and an Amended Certificate of Limited Partnership (the "Certificate") dated effective June 19, 1989. Ethel E. Danzansky, Stephen I. Danzansky, and Richard F. Danzansky are the General Partners of the Partnership.

B. The parties hereto desire to amend the Agreement and Certificate to reflect the substitution of RFD Associates, LLC as a limited partner of the Partnership.

NOW, THEREFORE, in consideration of the foregoing, of the mutual promises herein contained, and of other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the undersigned parties agree, and do hereby amend the Limited Partnership Agreement and the Amended Certificate of Limited Partnership of DANZANSKY FAMILY ASSOCIATES

1. Effective as of the date hereof, RFD Associates, LLC is hereby admitted as a substituted Limited Partner of the Partnership with 5,655.89 units of limited partnership interest in the Partnership. The execution of this Amendment by Richard F. Danzansky, the Managing Member of RFD Associates, LLC, shall constitute the agreement of RFD Associates, LLC to all of the terms and provisions of the Limited Partnership Agreement and Restated Certificate of Limited Partnership of the Partnership, as amended.

2. The present Exhibit A of the Limited Partnership Agreement and the Amended Certificate of Limited Partnership of the Partnership is hereby deleted, and the Exhibit A attached hereto and incorporated herein by this reference shall be the Exhibit A of the Limited Partnership Agreement and the Amended Certificate of Limited Partnership of the Partnership, as amended.

3. The signing of this Amendment by the General Partners of the Partnership, for themselves and for each Limited Partner pursuant to the power of attorney set forth in the Partnership Agreement, does and shall constitute the consent of the Partners to said substitution of RFD Associates, LLC as a

Limited Partner of the Partnership, and any present or future references to the terms "Partner(s)" or "Limited Partner" by the Limited Partnership Agreement or the Amended Certificate of Limited Partnership, or any amendment thereto, shall be deemed to include RFD Associates, LLC to the extent of the 5,655.89 units of limited partnership interest assigned to it by RFD Associates Ltd.

4. Except as hereby amended, the Limited Partnership Agreement and the Restated Certificate of Limited Partnership of the Partnership is hereby affirmed in all respects.
