AGREEMENT AND CERTIFICATE OF ASA, LTD.**

Pursuant to the authority of Section 620.109 of the Florida Revised Uniform Limited Partnership Act (1986) and of Section 620.1202 of the Florida Revised Uniform Limited Partnership Act (2005), the undersigned, constituting the sole general partner of ASA, LTD., a Florida limited partnership (the "Partnership"), submits the following:

1. The current name of the Partnership is ASA, LTD.
2. The date of the filing of the original Limited Partnership Agreement and Certificate of the Partnership (the "Certificate") was December 23, 1981.
3. Pursuant to Section 620.2204, Florida Statutes (2005), the Partnership shall be subject to the Florida Revised Uniform Limited Partnership Act (2005).
4. Pursuant to Section 620.1102(10), Florida Statutes (2005), the Partnership is a Florida limited liability limited partnership.
5. Section 2.2 of the Certificate is hereby deleted in its entirety and the following is substituted in lieu thereof:

"2.2 Name and Office. The Partnership shall be conducted under the name and style of ASA, LLLP. The principal office of the Partnership shall be 2700 Westhall Lane, Suite 140, Maitland, Florida 32751. The General Partners may at any time change the location of such principal office and shall give notice of any such change to the Limited Partners."

6. Pursuant to Section 620.1104(3), Florida Statutes (2005), the first paragraph of Section 2.4 of the Certificate is hereby deleted in its entirety and the following is substituted in lieu thereof:

"2.4 Term. The Partnership shall begin business upon the issuance of a charter by the Secretary of the State of Florida and shall have a perpetual duration, except that the Partnership shall be dissolved and its assets liquidated upon the happening of any of the following events:"

7. Section 4.1(1) of the Certificate is hereby deleted in its entirety and the following is substituted in lieu thereof:

"4.1(1) Names and Addresses. The name and business address of the general partner of the Partnership is:


