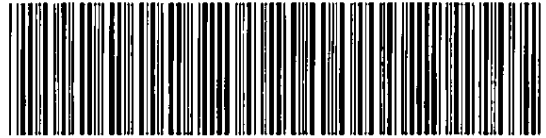

ARTICLE III


