RESTATEMENT OF CERTIFICATE OF LIMITED PARTNERSHIP

We, the undersigned, being the corporate general partner of DELAND PLAZA ASSOCIATES LTD., desiring to amend and restate the Certificate of Limited Partnership previously filed with the Department of State of the State of Florida on July 7, 1999, do severally certify and swear as follows:

1. The Restatement of Certificate of Limited Partnership is hereby amended by the deletion of Article IV., (III) and (IV) and its replacement as follows:

Article IV., III.

The provision of the Certificate of Limited Partnership or any restatement thereof, relating to the name and mailing address of the general partner is amended to reflect the deletion of all references to "General Partner" or "Corporate General Partner" and its substitution with the phrase "Managing General Partner" in lieu thereof; so that the sole general or corporate general partner shall henceforward be identified as the Managing General Partner.

ARTICLE IV., IV.

The provision of the Certificate of Limited Partnership as amended relating to L. M. Equities Corp. is amended to reflect the withdrawal of L. M. Equities Corp. as General Partner, and its replacement and substitution by Washington General Corporation, as Managing General Partner of the Partnership, effective as of April 1, 1999, such amendment being effective by revising said provision to read as follows.

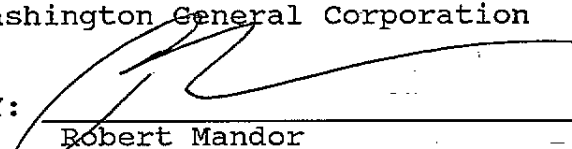
