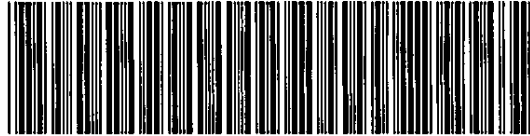

**FOURTH AMENDMENT TO THE AMENDED AND RESTATED CERTIFICATE AND
AGREEMENT OF LIMITED PARTNERSHIP OF
PINWOOD ASSOCIATES, LTD, A FLORIDA LIMITED PARTNERSHIP**
