Pursuant to the provisions of section 620.1203, Florida Statutes, MLA Alexander FMY LP (the "LP"), whose certificate was filed with the Florida Department of State on July 10, 2013 and pursuant to an Agreement and Plan of Merger effective July 15, 2015, assigned document number A13000000362, hereby submits this Certificate of Dissolution.

FIRST: The partners of the LP understand that it is administratively burdensome to maintain and continue the LP. The amount of the LP assets may not be sufficient to justify the administrative expenses and efforts.

Pursuant to Section 13.1.1 of the Amended and Restated MLA Alexander FMY LP Agreement, the LP shall be dissolved upon the consent of all of the general partners and a majority of the limited partners owning a majority of the rights to receive distribution.

The general partner of the LP KA ALEXANDER MANAGEMENT, LLC has consented to the dissolution of the LP.


Limited partners owning 88.88% of the rights to receive distribution from the LP have voted to dissolve the LP.

SECOND: There are no known claims.

THIRD: The effective date of the Dissolution of the LP shall be the date of filing of this Certificate.
