AMENDMENT TO AGREEMENT AND CERTIFICATE OF LIMITED PARTNERSHIP

ACCOUNT ON MILES

THIS AMENDMENT to the Agreement and Certificate of Limited Partnership of Wilson West Apartments, Ltd. - C. It is the desire of the parties that the Assignees be substituted as limited partners of the Partnership to the extent of the partnership interests assigned to each Assignee, and that pursuant to such desire, the Partnership Agreement be amended to reflect said substitution.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the undersigned parties agree and certify that the Agreement and Certificate of Limited Partnership of WILSON WEST APARTMENTS, LTD. is amended to provide as follows:

Schedule A of the Partnership Agreement is hereby amended to delete the present Schedule A and to insert in lieu thereof the Schedule A attached hereto and incorporated herein by this reference.

- 2. The Assignors hereby withdraw from the Partnership. The Partnership hereby accepts such withdrawal, and Assignors shall hereafter cease to be partners of the Partnership.
- 3. It is provided and agreed that the Assignees shall be and hereby are substitute limited partners of the Partnership to the full extent of the limited partner interests assigned to each Assignee; (i) the signing of this Amendment by the parties hereto does and shall constitute the consent of all Partners to said substitution; (ii) any present or future references to the terms "Partner(s)" or "Limited Partner(s)" by the Partnership Agreement, or any amendment thereto, shall be deemed to include each Assignee to the extent of the limited partner interests assigned; and (iii) the execution of this Amendment by each Assignee shall constitute the agreement of each Assignee to all of the terms and provisions of the Partnership Agreement of the Partnership, as amended.
- 4. Except as hereby amended, the Partnership Agreement of the Partnership, as amended, is ratified and affirmed in all respects.
