## FIRST AMENDMENT TO AGREEMENT OF LIMITED PARTNERSHIP

THIS FIRST AMENDMENT TO AGREEMENT OF LIMITED PARTNERSHIP is entered into this 27 day of January, 2000, by and between JAMES P. KNIGHT (hereinafter referred to as the "General Partner") and JAMES P. KNIGHT, LEONARD SAMUELS and ROBERT McNALLY (hereinafter referred to as "Limited Partners"); A13203
