SECOND AMENDMENT TO LIMITED PARTNERSHIP AGREEMENT

THIS SECOND AMENDMENT TO PARTNERSHIP AGREEMENT, is made and entered into as of the 22nd day of June, 1998, by and among George J. Baxter, Peter Irving, and Robert S. Kerr, Jr. (the "General Partners") and the persons signing this Agreement as limited partners (the "Limited Partners"), with the Limited Partners and the General Partners being collectively referred to as the "Partners".

WHEREAS, the Partners entered into a Limited Partnership Agreement (the "Partnership Agreement") creating a Florida limited partnership to be operated under the name South Tampa, Ltd.; and

WHEREAS, Article 19 of the Partnership Agreement allows the Partnership Agreement to be amended upon Agreement of the General Partners, together with the consent of Limited Partners holding at least a majority of the Limited Partnership Interests, except that the consent of all the Limited Partners is required for any amendment to Article 2, 5, 7, 8, 16.01, 17, and 19: and

WHEREAS, 100% of the General Partners and the Limited Partners have agreed to terms and conditions of this Second Amendment;

NOW, THEREFORE, the Partners agree to amend the Partnership Agreement as follows:

1. The following provisions shall be added to Section 7.02(a) of the Partnership Agreement:

For purposes of the distribution of the net proceeds of the sale of approximately 10.79 acres to Brandon Crossing Partners, Ltd., the net investment in the property sold shall include approximately 8 acres of property to the north of Delaney Creek, as well as the 10.79 acres. If and when the 8 acres of property to the north of Delaney Creek are sold, the proceeds of such sale shall be distributed first, to repay outstanding advances and interest thereon, if any by any General Partner, and second, 70% to the Limited Partners as a group (in proportion to their respective ownership of Interests) and 30% to the General Partners as a group.

2. All other terms and conditions of the Limited Partnership Agreement, as previously amended, shall remain in full force and effect, except as modified by the terms of this Amendment.
