**SIXTH AMENDMENT TO CERTIFICATE OF AGREEMENT  
OF LIMITED PARTNERSHIP**

WHEREAS, the Estate of Taylor Budd Williams has assigned, sold, and transferred ten and one half (10.5%) of his interest in Golden Leaf Apartments, Ltd., a limited partnership existing under the laws of the State of Florida, to Debora R. Williams, as Trustee of the Taylor Budd Williams Family Trust u/w/d 9/5/07, with the approval of the Managing General Partner. The original certificate of limited partnership was filed with the Secretary of State on March 29, 1983.

NOW, THEREFORE, subsection 2.02 and 3.05 are amended as follows:

**2.02    Limited Partners**

Graves Williams, Wilton R. Miller, W. Robert Olive, Edward Cantey Higdon, Kelly Wade Williams, Mary Taylor Olive, and Debora R. Williams, as Trustee of the Taylor Budd Williams Family Trust u/w/d 9/5/07 shall be the Limited Partners of the Partnership. All persons, firms and organizations who from time to time are Limited Partners in the Partnership are sometimes hereinafter collectively referred to as "Limited Partners" and individually as "Limited Partner." It is understood that each and every Limited Partner shall have the right to sell, transfer or otherwise divest himself or herself of his or her limited partnership interest subject only to said additional limited partners being approved by the Farmers Home Administration.

**3.05    Distribution:**

Profits, losses and cash flow of the Partnership shall be distributed among General and Limited Partners in accordance with their percentage of ownership as follows:
