

## FIRST AMENDED AND RESTATED CERTIFICATE OF LIMITED PARTNERSHIP

## II. LOCATION OF THE PRINCIPAL PLACE OF BUSINESS

## V. <u>TERM OF PARTNERSHIP</u>

The partnership shall commence on the issuance by the Florida Department of State of the Certificate of Authority for the partnership to transact business, and continue thereafter for an unstipulated time ending:

- (1) On the dissolution of the partnership by law;
- (2) On dissolution at any time agreed on by all the partners; or
- (3) On dissolution following sixty (60) days' written notice by the general partner to the limited partners.

The death or legal incapacity of any limited partner shall not cause a dissolution of the partnership, but the rights of such limited partner to receive a share of the profits and losses, as well as all of his other rights hereunder, shall devolve on his personal representatives and heirs and the partnership shall continue as a limited partnership. A limited partner shall have the right to assign or sell his interest to anyone but only with the written consent of the general partner. Such successor limited partners shall have all the rights and obligations of a limited partner, upon compliance with all requirements with respect thereto and execution of all documents necessary to continue the partnership in existence. The personal representatives, heirs, and assigns of the limited partners shall be liable for all their obligations as limited partners and shall be bound by the terms of this agreement.
